## Level 2 Telescope Loan Agreement

By signing and providing my information below, I acknowledge that I understand the following terms of this agreement through **Second Light™, a telescope loaning program by Experience Daliona, LLC** (referred to henceforth as 'Experience Daliona'). I agree to saving my payment card and information to my customer profile through Experience Daliona's payment portal (Square, Inc), and I will pay any penalties incurred through damages to the telescope or late fees incurred through my failure to attempt to return the telescope to Experience Daliona by the agreed-upon due date, as defined below:

- I will attempt to return the telescope to Experience Daliona no later than after a period of 14 days, falling between the *Start Date* and *End Date*, which will be defined in this agreement, unless otherwise granted an extension (the *Extension Date*), and that failure to attempt to return the telescope by 11:59pm on the *End Date*, or by 11:59pm Eastern Time on the *Extension Date*, will result in a fee of \$2.25 USD per day beyond the date, charged to my card-on-file or my payment of cash, and not charged more than once per loan agreement, upon return of the telescope to Experience Daliona after the loan period has expired;
- I acknowledge that my failure to attempt to return the telescope to Experience Daliona at the end of 28 days beyond the *End Date* or the *Extension Date* will result in Experience Daliona placing an automatic \$100.00 USD replacement charge to my card-on-file, plus the accrued daily late fee of \$2.25 USD per day for each day of that 28-day time frame, for a total of \$163.00 USD charged automatically to my card-on-file;
- I acknowledge that I may contact Experience Daliona at the email [experiencedaliona@gmail.com](mailto:experiencedaliona@gmail.com), or through the Request Extension page found on [www.experiencedaliona.com](http://www.experiencedaliona.com), to request an *Extension Date*;
- Should Experience Daliona grant my extension, no late fees will be incurred until after 11:59pm on the new *Extension Date*;
- Should Experience Daliona deny my extension, I must attempt to return the telescope by 11:59pm on the original *End Date* defined in this agreement;
- Should Experience Daliona offer in writing, either via email or text message, or on video, to have me return the telescope beyond the *End Date* or *Extension Date*, I understand that Experience Daliona will not charge me daily late fees of \$2.25 USD beyond either date;

- I will pay an incurred fee of \$100.00 USD for any damages that did not exist upon my receiving the telescope, or missing items that were included upon my receiving the telescope, which prevent the telescope from performing its natural and intended functions;
- I will use the telescope I receive according to its intended functions to the best of my knowledge, abilities, and common-sense reasoning.

Experience Daliona will notify you of your upcoming due date three (3) days prior to the agreed-upon *End Date* defined in this agreement, or the notified *Extension Date*, the date by which you must attempt to return the telescope to Experience Daliona. Experience Daliona will communicate a suggested time, date, and location to return the telescope. If necessary, secondary arrangements will be agreed upon.
